**Scope and Manner of Services**

One or more members of BZ will arrive at the client's place of event and set up a playing field consisting of up to 12 pop-up bunkers. Other equipment used during the event, dependent upon requested package level, will be up to:

- 20+ Dart blasters
- 20+ Pairs of safety glasses
- Hand Sanitizer
- 2 Flag stations
- 2 Ammo boxes
- 400+ foam darts
- 8+ Inflatable/Pop-up bunkers
- 1 Speaker system
- \*Misc. blaster accessories

**Payment for Services Rendered**

The Client shall pay in full for services to be rendered, on the day of the event date before the start of play. A non-refundable deposit of \$75.00 is due within 48 hours from the time the event is booked.

### **Inclement Weather and Cancellations**

**The \$75 event deposit is non-refundable.**

If the event is canceled due to inclement weather, (as agreed on by both you and a member of BZ) we will work to reschedule the event for the closest convenient time, and reservation deposit shall rollover to the next reservation date. If event is rescheduled a second time a new reservation deposit will be required.

### **Additional Information**

Depending on rental package one or more members of BZ will remain on-site and facilitate dart tag games. Actual play time will follow your package details. If players are in the middle of a game when time expires, we will continue to play until the game is finished.

### **Travel Fees**

Depending on event location there may be an additional Travel Fee assessed. There is no travel fee for 0-25 miles from select Battle Zone location. There is a \$25 travel fee for 25-50 miles from select Battle Zone location. There is a \$50 travel fee for 50-100 miles from select Battle Zone location.

### **COVID-19 Information**

All equipment will be thoroughly sanitized using a CDC recommended sanitizer. Safety glasses and darts will be brought for each player and will be the player's to keep. We will provide hand sanitizer at the game table for all guests and players. Battle Zone staff will wear a face covering at all times. All players must sign group waiver and provide contact information for contact tracing records.

The person(s) or organization hiring this service and equipment will be fully responsible and liable for any damage or injury occurring from or as a result of misuse, careless use, or recklessness of players, and/or the person(s) or organization hiring this service.
